 S.I. 349 of 2011 - European Communities (Carriage of Dangerous Goods by Road) (ADR Miscellaneous Provisions) Regulations

ADR 2013

- New provisions concerning the carriage of dangerous goods packed in excepted quantities.
- New criteria for the classifications of environmentally hazardous substances (aquatic environment).
- Updated requirements for the construction and testing of pressure receptacles, small receptacles containing gas (gas cartridges) and fuel cell cartridges containing liquefied flammable gas.
- Documentation: Instructions in writing
