



Dangerous Goods by Sea Introductory IMDG Course

One day course (9.00 – 5.00 pm) aims to provide distribution and warehouse personnel with a practical understanding of current Dangerous Goods by Sea regulations.

Practical guidelines on Loading and Inspection of Cargo Transport Units are covered.

New responsibilities have come into effect, from the International Maritime Association for those involved in consigning and transporting Dangerous Goods by sea in compliance with IMDG rules 37–14. General awareness / familiarisation and safety training should be given to relevant staff, whose job functions concern the carriage of dangerous goods by sea.
