



## ***IMDG Dangerous Goods by Sea Advanced Corporate Course***

New responsibilities from the International Maritime Association require those involved in consigning and transporting Dangerous Goods by sea. The new IMDG Code Amendment 38 -16, requires that general awareness / familiarisation training, function-specific training and safety training be given to relevant shoreside staff, whose duties concern the carriage of dangerous goods by sea.

This internationally recognised course is designed for shore based traffic and operations staff of consignors and cargo agents, as well as for shipping department staff of manufacturers, wholesalers, importers and exporters and hauliers.

### **Course Benefit Assurance**

A detailed review of the Dangerous Goods by Sea regulations implications will take place with a pre-course questionnaire review followed by ongoing telephone support for the month following the course.

Upon successful completion of continuous assessment during the course participants will receive an **MSO approved Dangerous Goods by Sea Certificate in accordance with the IMDG Code.**
