- S.I. 349 – European Communities (Carriage of Dangerous Goods by Road) (ADR Miscellaneous Provisions)

Regulations

- *New provisions concerning the carriage of dangerous goods packed in excepted quantities.*
- *New criteria for the classifications of environmentally hazardous substances (aquatic environment).*
- *Updated requirements for the construction and testing of pressure receptacles, small receptacle containing gas (gas cartridges) and fuel cell cartridges containing liquefied flammable gas.*
- *Documentation: Instructions in writing*
